As stated in Isaiah 56:7, "My House shall be called a house of prayer for all peoples." It is the policy of Temple Beth Ami to welcome all members and not refuse membership privileges to any person suffering financial hardship. To carry out that policy, the Temple's Financial Secretaries have the responsibility to ensure that requests for reductions are justified and annual support is shared equitably.

- All accounts must be current for last year (July 2017 to June 2018) to be considered.
- <u>Each year's circumstances are reviewed separately. A reduction in Annual Support last year does NOT automatically mean that a reduction will be granted for the coming year.</u>
