## Gan Ami Health Form Instructions

The following document provides a list of each form required for the upcoming school year along with deadlines and instructions. These forms can be found on our <u>school website</u>. Please contact our Administrative Manager, <u>Emily Katz</u>, if you have any questions.

## **Gan Ami Required Forms for School Attendance**

These forms are all to be completed by parents. Not every form applies for every child—be sure to read the descriptions. These forms must be turned in by July 31, 2023.

- First Year Families: Child Information Form
  - Only for children starting their first year at Gan Ami
- Returning Families: Child Information Form
  - o Only for children who have already attended Gan Ami for a year
- Bets and First Year Families: Speech and Language Screening Permission
  - o Only for Bet children and those Gimels and Dalets that are new to Gan Ami this year
- Gimels and Dalets: Vision and Hearing Screening Permission
  - Only for Gimel and Dalet children

## **State of Maryland Early Childhood Health Forms**

All the following forms must be submitted for all children. These forms must be signed and dated between June 5-July 31, 2023 and turned in by July 31, 2023. Be sure to submit these forms to your pediatrician no sooner than June 5 (and as soon thereafter as possible). Do not have the forms signed any earlier than June 5. Asking your pediatrician to complete these forms in June generally does not require an office visit if the doctor has examined the child within the past year.

- Health Inventory
  - o Part I completed by parent and Part II completed by doctor
  - Please double check that your pediatrician fills out the OCC1215 for the Health Inventory, and NOT the Maryland State Inventory Form (latter form is meant for elementary school aged children)
- Immunization Certificate
  - To be completed by doctor
- Blood Lead Testing Certificate
  - To be completed by doctor
  - Note that even if your child did not live in the listed zip codes, this form is required
- Emergency Form
  - To be completed by parent
  - Make sure to sign and date the bottom

## **Additional Required Forms if Applicable**

These forms are only to be filled out for children who have conditions such as allergies, seizures, or asthma. If relevant, forms must be signed and dated between June 5-July 31, 2023 and turned in by July

31, 2023. Children with allergies must fill out the Allergy Action Plan, Medication Administration Form, and a Parent Nut and/or Non-Nut Permission Form. Children with medications will receive instructions in August on when/where to drop off.

- Allergy Action Form

- Nut Allergy Parent Permission for School Supplied Foods
  - o To be filled out by a parent
- Non-Nut Allergy Parent Permission for School Supplied Foods
  - o To be filled out by a parent
- Medication Administration Authorization
  - o To be filled out by a doctor
- Asthma Action Form
  - o To be filled out by a doctor
- Seizure Medication Administration Authorization
  - o To be filled out by a doctor
